**REVISED RECOGNITION ORDER**

In terms of Section 14(1) of the NCTE Act, 1993, Maharashtra Mandal's Chandrashekhar Agashe College of Physical Education, Gultekadi, Pune, Maharashtra had submitted the application on 13.04.1998 to the Western Regional Committee of the NCTE for grant of permission for conducting of B.P.Ed. course.

2. AND WHEREAS, recognition was granted to the institution namely, Maharashtra Mandal's Chandrashekhar Agashe College of Physical Education, Gultekadi, Pune, Maharashtra (WRC/OAPW0144/114040) under section 14 of NCTE Act, 1993 for conducting B.ED. (Phy. Edu.) course vide order dated 23.11.1998 for an annual intake of 120 students.

3. AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institutions and the reply was received on 23.01.2015.

4. AND, WHEREAS, Revised Recognition order was issued for three basic unit of 150 students of 50 (fifty) each to the institution on 08.12.2015.

5. AND, WHEREAS, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided that "**Follow up of Revised Orders for B.P.Ed. courses:** The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item"

6. AND WHEREAS, the Show Cause Notice of compliance issued on 03.10.2016 and reply submitted by the institution on 27.10.2016.

7. AND WHEREAS, the reply was placed in 292<sup>nd</sup> Meeting held on May 15-17, 2018 of WRC and the Committee decided that "**Consequent to the issue of Revised Recognition order, Show Cause Notice dated 03.10.2016 was issued for non-compliance. The institution vide reply dated 21.10.2016 has submitted the staff profile of 4 Associate Professors and 11 Assistant Professors besides other subsidiary staff. The institution needs to appoint a Principal in the rank of Professor. The institution needs to submit additional FDRs for 4.00 lakhs in joint account in original.**

**Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn.**

Further, reference is made to letter dated 23.03.2016 regarding the change of the nomenclature of the course from B.Ed. (Physical Education) to B.P.Ed. and also M.Ed. (Physical Education) to M.P.Ed. The change is permitted. This change in nomenclature should be incorporated in the files. These courses will be governed by the Appendices-VII & VIII of NCTE Regulations, 2014."

8. AND WHEREAS, the Clarification/Compliance letter issued on 24.05.2018 and reply submitted by the institution on 18.06.2018.

9. AND WHEREAS, the reply was placed in 304<sup>th</sup> Meeting held on April 02<sup>nd</sup> to 04<sup>th</sup>, 2019 of WRC and the Committee decided that "**The original file of the Institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made:**

*As per decision of WRC in its 292<sup>nd</sup> meeting change of nomenclature was permitted from B.Ed.(Physical Education) to B.P.Ed.*

*The institution complied the condition of revised recognition order vide reply dated 14/06/2018.*

**Hence, the committee decided to issue corrigendum for change of nomenclature. Formal recognition order for continuation of B.P.Ed. course with an intake of one basic unit (100) in accordance with appendix-7 of NCTE Regulations 2014 be issued."**

In compliance of above, this formal revised recognition order is issued to the institution namely **Maharashtrian Mandal's Chandrashekhar Agashe College of Physical Education Gultekadi, Pune , Maharashtra** for conducting B.Ped. course with an intake of one basic unit of 100 (one hundred) students is permitted to continue further.

**Note :** Revised recognition order issued earlier vide letter No WRC/OAPW0144/114040/2015/156717-723 dated 08.12.2015 may be treated as cancelled.


