Introduction

The student council of CACPE gets elected as per the guideline by Savitribai Phule Pune University, Pune, (Nomination of students from National Service Scheme, National Cadet Corps, Sports and Cultural Activities etc. on Students' Council)

What is Student Council

A Student Council is a representative element through which students can be involved in managing college functions, collaboratively working with college management and staff and parents for the benefit of the college and its students.

Policy of the Student Council

1. To improve communication between students, staff and parents
2. -To promote an environment lead to educational and personal development
3. -To assist the management and staff in the development of the college
4. To represent the views of the students on general concern to them
5. To involve college students in the decision-making process and day to day activities of the college

The role of the Student Council

Main function of Student Councils is to support the aims and objectives of the Council and promote the development of the college and the welfare of its students.

Student Council must work closely with college faculties. Council must regularly consult with the students in the college and must involve as many students as possible in the college activities. Some of the activities, student council may undertake are as:

Representing the views of the student body to the college: Speaking and listening to the students, considering their views and concerns, and discussing these with the college management on behalf of the students.

Promoting good communications within the college: Student Council will work for efficient communication within the college students and Faculty. Keeping students and staff informed of activities through notice-boards or through a regular newsletter.

Supporting the educational development and progress of students:

A Student Council will contribute to the efficient learning environment for students in the college by making up study groups for students or study clubs, or organising various activities such as exhibition, Reading club, Writing Club, Hobby Club etc.

Contributing to the development of college policy: The Student Council can actively contribute to the development of college policy in a various areas as bullying, uniform requirements, code of conduct or extra-curricular activities.

Assisting in college sporting and cultural activities:

Student Councils will help in organising and conducting different cultural, sports and other activities within the college.

Assisting with or organising Social events: Student Councils will organise social events both within the college and involving the wider community.

Establishing a Student Council

- Students of the college will be informed through notice about the establishment of a student council in the college.
- Students willing to nominate themselves can fill up the form prescribed by the college along with required documents and must fulfill all the necessary procedures and eligibility for the same post.
- The Principal, Teacher In-charge of the student council along with all other staff will complete the selection procedure by conducting an interview.
- Then students council will be declared and felicitated in front of the college students
- First meeting of the student council is conducted where the Principal, Teacher In-charge of the student council and all the faculty coordinators of a particular department orient them about the functioning of the student council.
- Meeting of the Student council is held every month or two month or whenever it is required.
- Student council under the guidance of faculty of the CACPE carry out all the necessary functions and by involving all other students in that activity help faculty to make any program/activity successful.

Eligibility for Student Council

- Students must be engaged in full time studies in CACPE.
- Students should have not completed seven academic years from the first entry to higher education.
- Students should have not been punished by the competent authority for indulging in unfair means in any university examination or for committing any misconduct;
- Students should have not been convicted for any offence involving moral turpitude.
- Students should have read the notification of election and fulfil the prescribed eligibility conditions for the candidature.

Size and Composition of a Student Council

The size and composition of a Student Council shall be determined as per the guidelines by the SPPU, Pune. Following table shows the composition student council recommended by SPPU, Pune

Selection of Student Council

As per the guidelines of the Savitribai Phule Pune University, Pune (Nomination of students from National Service Scheme, National Cadet Corps, Sports and Cultural Activities etc. on the Students' Council), Nomination of students on the Students Council will be as follows.

The nomination from National Service Scheme, National Cadet Corps, Sports and Cultural Activities to University Department Students' Council/ College Students' Council / University Students' Council shall be done by the Vice Chancellor on the basis of outstanding performance of the highest level by a student in the respective activities in the preceding academic year as prescribed herein below -

(1) From National Service Scheme:- The student shall have participated for at least one year in the National Service Scheme programme as an enrolled volunteer and shall have attended a minimum 120 hours of work in the year and attended at least one camp of minimum seven days' duration. Such student shall have the highest level of performance/achievement in the participation of camps, competitions, parades and any other event at Regional / State / National / International level as National Service Scheme volunteer of the college or institution or University Department, as the case may be, in the preceding year.

Student Representative of National Service Scheme will be selected amongst all

candidates after interview by the Teacher incharge of National Service Scheme of CACPE

(2) From National Cadet Corp:- The student shall have undergone formal NCC training in Senior Division for at least one year and shall have attended at least 75% of NCC parades and shall have attended at least one NCC Annual Training Camp (ATC). Such student shall have the highest level of performance/ achievement in the NCC 'B' & 'C' certificate examination and/or in the participation of camps, competitions, parades and other event at Regional / State / National / International level as NCC Cadet of the college or institution or University Department, as the case may be in the preceding year.

Student Representative of National Cadet Corps will be selected amongst all candidates after interview by the Teacher incharge of National Cadet Corps of CACPE

(3) From Sport :- The student shall have represented the college in the inter-collegiate tournaments at least once. Such student shall have the highest level of performance/achievement as the individual or team representative of the College/ institution /University Departments in the sports tournaments, competitions, events at the inter-collegiate / inter-zone / inter-university sports tournaments organized by the university or Association of Indian Universities or the State or Central Government authorities as the representatives of the college or institution or University, as the case may be, in the Preceding Year : provided that, in case of non-availability of the facilities at the college or institution or University Department, as the case may be for a particular type of sports, a student participating in the sports event as above shall be considered eligible for such nomination, even if he is not representing the college or institution or University Department, as the case may be.

Student Representative of Sport will be selected amongst all candidates after interview by the Teacher incharge of Extramural Sports and Principal of CACPE

(4) From Cultural Activities:- A student shall have the highest level of performance/achievement as an individual or team representative of college or institution or University Department, as the case may be, in the cultural competitions and events such as dance, drama, music, elocution, debate, literature, fine arts, etc. organized

by the University or Association of Indian Universities or any State or Central Government Authorities at the inter-collegiate or inter-zone or inter-university or State or National or International level as the representatives of the college or institution or University Department, as the case may be, in the preceding year.

Student Representative of Cultural Activities will be selected amongst all candidates after interview by the Teacher incharge of Cultural Activities of CACPE

(5) Class Representative: Class representative for each class of the courses offered by the CACPE will be selected based on the maximum votes from the class students.

(6) Lady student representative: Lady representative will coordinate all the activities related to Women Empowerment in the college like organizing talk or Self Defense Workshop for female students or solving their problems in the college or being representative of all the female students of CACPE.

Lady Representative will be selected amongst all candidates after interview by the Lady Faculty or Teacher in-charge of Nari Mach of CACPE

(7) Backward Class Representative: Student belonging to Scheduled Castes or Scheduled Tribes or e-notified Tribes (Vimukta-Jatis) or Nomadic Tribes or Other Backward Classes.

Backward Class Representative will be selected amongst all candidates after interview by the Principal and Teacher in-charge of Student Council of CACPE.

(8) Intramural Coordinator: The student having represented the college in the inter-collegiate tournaments at least once. Such student must have the experience or ability to organize or manage the sports events. Students also must possess the ability of liaising and communication.

Intramural Coordinator will be selected amongst all candidates after interview by the Teacher in-charge of Intramural of CACPE.

(9) ICC Representative: CACPE has Internal Compliance Committee as per the guidelines by Sexual Harassment Act 2013. Every Year one female student gets selected as a member of ICC for that academic year.

ICC Representative student will be selected amongst all female students after interview by the Chairmen ICC of CACPE.

(9) General Secretary: General Secretary will be selected from the MPEd Course (Preferably from Second Year Students). Student, good at communication, Self Discipline, Having very cordial relations with students of CACPE, Having good administrative and Organisational qualities will be Nominated for this post by the principal. (Incase of many deserving students, the Principal can ask them to apply for this post and based on the interview, GS will be Decided.)

(10) Secretary: Secretary will be selected from the BPEd Course (Preferably from Second Year Students). Student, good at communication, Self Discipline, Having very cordial relations with students of CACPE, Having good administrative and Organisational qualities will be Nominated for this post by the principal. (Incase of many deserving students, the Principal can ask them to apply for this post and based on the interview, GS will be Decided.)

Removal of a Member

The Student Council member may remove for a continuing failure to attend meetings of the Student Council, or for demonstrated lack of commitment to the purposes of the Student Council, or for stated misconduct.

Such a decision will be taken on the basis of a majority vote of the Council and decision of the Principal of CACPE.

Dissolution of a Student Council

Student Council's term will expire at the end of the academic year.
