RESOLUTION — The Maharashtra Mandal, Pune has started a College of Physical Education—called "Chandrashekhar Agashe College" of Physical Education at Pune affiliated to the Poona University, Faculty of Education, and has started a post Graduate B. Ed. (Physical Education) Course with effect from 1977-78. As this course is academically on par with the B. Ed. course in all respects, Government is pleased to direct that Graduates with a Degree of Bachelor of Education (Physical Education) of Poona University should be treated as trained graduates on par with other B. Ed. teachers for the purpose of status, pay - scales, promotions, etc. and should be treated as qualified Physical Education Teacher for service in Secondary Schools or as qualified Directors of Physical Education in Colleges and Universities.

2. The Director of Sports & Youth Services, Maharashtra State, Pune should be requested to forward copies of these orders to all recognised Secondary Schools and Colleges in the State.

3. This Resolution issues in consultation with the Education & Youth Services Department's / General Administration Department / Finance Department vide Finance Department's unofficial reference No. 1995 / EXP. 11, dated the 15-11-1977.
